The board was unable to find a total of four years of supervisory experience in the actual construction or maintenance of highways as required by Tenn. Code Ann. § 54-7-104. Specifically, the board was not able to conclude from the employment history listed in Mr. Burke's application – in which Section 5 for listing specific experience and projects was left completely blank – demonstrated the required supervisory experience in the actual construction or maintenance of highways.

The board was unable to find a total of four years of supervisory experience in the actual

construction or maintenance of highways as required by Tenn. Code Ann. § 54-7-104. Specifically, the employment history listed in Section 4 failed to demonstrate the necessary four (4) years of supervisory experience in highway construction or maintenance. Mr. Slusser's employment at Griffith's Landscaping from 2003 to 2012, although appearing to be in a supervisory capacity, was in landscape design, not highway construction or maintenance. Mr. Slusser's employment at Roach's Paving Company and Weakley County Highway Department since 2009, although appearing to be in highway construction or maintenance, did not appear to be in a "supervisory" capacity. Likewise, the specific experience and projects listed in Section 5 failed to demonstrate the necessary four (4) years of supervisory experience in highway construction or maintenance.

White County - Robert Howard Austin - Denied - (Belen/Helton)

The board was unable to find a total of four years of supervisory experience in the actual construction or maintenance of highways as required by Tenn. Code Ann. § 54-7-104. Specifically, Mr. Austin's experience as owner and CEO of Austin's Machine Shop since 1998 did not appear to include any experience in highway construction or maintenance as required by statute.

White County – Gaylen Wade Barlow – Deferred – (Fortner/Wormsley)

The board seeks clarification and additional information showing that Mr. Barlow has a total of four years of supervisory experience in the actual construction or maintenance of highways as required by Tenn. Code Ann. § 54-7-104. Specifically, based on his employment history listed in Section 4 of his application, Mr. Barlow's only supervisory experience in highway construction or maintenance appeared to be as a crew leader for the City of Sparta for three (3) years, for all or a portion of 2008 to 2011. However, in Section 5 Mr. Barlow appeared to serve in the role of project foreman in the construction or maintenance of highways during a portion of his employment for the White County Highway Department from 1992 to 2005, although he listed his title as "heavy equipment operator" during his employment there. To determine whether Mr. Barlow meets the necessary four (4) years of supervisory experience in highway construction of maintenance, the board seeks additional information on (i) Mr. Barlow's exact dates of employment as crew leader for City of Sparta and his role and duties during that time, and (ii) any projects or duties while employed at the White County Highway Department that qualify as supervisory experience in highway construction of maintenance.

White County – Kenneth Prince Cotten – Denied – (Wormsley/Helton)

The board was unable to find that Mr. Cotton met the requirements of Tenn. Code Ann. § 54-7-104. Section 2 of the application did not indicate under which part of the statute Mr. Cotten was seeking qualification. The majority of the application was blank and did not demonstrate that Mr. Cotten met the necessary qualifications under any option for qualification.

White County – Charles A. Hutson – Denied – (Belen/Helton) Yes – Votes – Belen, Helton, Lim No – Votes – Fortner, Wormsley

The board was unable to find a total of four years of supervisory experience in the actual construction or maintenance of highways as required by Tenn. Code Ann. § 54-7-104. Specifically, the employment history and specific experience listed in Sections 4 and 5 of the application did not demonstrate that Mr. Hutson's experience since January 18, 2018 is in a supervisory capacity in "highway construction or maintenance."

The board discussed setting the next meeting for the week of January 24, 2022.

Because there was no other business before the board, Chairman Lim adjourned the meeting at 2:08 p.m. Central Standard Time.
