State Election Commission Meeting
February 24, 2022

The State Election Commission meeting was called to order by Chairman Blackburn, at 11:00 a.m. Central Daylight Time, February 24, 2022. The following members and staff were telephonically connected: Commissioners Barrett, Blackburn, Duckett, Eldridge, McDonald and Wheeler; Coordinator Mark Goins and Kathy Summers, Elections Specialist.

Pursuant to TCA § 8-44-108(a)(3), the determination of necessity for conducting the State Election Commission meeting by phone was to make county election commission appointments.



Commissioner Barrett made a motion to accept a resignation which is effective February 25, 2022, and appoint a replacement to be effective on February 25, 2022, seconded by Commissioner McDonald. The State Election Commission met by teleconference at 11:00 a.m., Central Time on Thursday, February 24, 2022, in the Elections Division, 7th Floor, William R. Snodgrass - Tennessee Tower. The notice requirements of TCA § 8-44-108 (b) were fully complied with.
