☐ Application Fee of \$10.00
☐ Proof of a Surety Bond
Prior to soliciting on behalf of a charitable organization:
☐ Submit a Completed Campaign Notice
Within ninety (90) days of the completion of a solicitation campaign, or within ninety (90) days after the fiscal year end of a multi-year campaign:
☐ Submit a Summary of Financial Activities Form for a Campaign
